## PAYMENT TERMS

As a courtesy, La Boom is holding a tentative reservation for Client's event until the above "Response Date." To book your event date and time please complete and sign this agreement and include payment of \$200 for the booking deposit (applied to the total fee due). Agreements and payment received after the Response Date are subject to availability. The deposit may be paid by cash, check, Visa, MC, Discover or Amex credit cards. The remaining balance is due no later than performance start time (unless otherwise previously arranged) and may be paid with the aforementioned credit cards, cash, cashiers checks, or company checks only. No personal checks please. If full payment is not received by the date of the event a 10% late payment fee will be added to the outstanding balance. All checks should be made payable to La Boom D.J. Productions. Client requests for extended playing time during event will be accommodated when feasible. Over-time requested may be made in half hour increments at a cost of \$50 per half hour, due by the end of the event.

## CANCELLATION

This Agreement cannot be canceled or modified except in writing by the Client and La Boom. If Client initiates cancellation less than 60 days prior to the event date the deposit will be forfeited. The deposit is not refundable for events canceled due to inclement weather. Client may prevent forfeiture of deposit by rescheduling an event, signing a new Entertainment Agreement within one month of cancellation and applying it to a substitute engagement performed within a year. Event rescheduling will be accommodated subject to availability.

## PROVISIONS

The Client shall ensure that: (1) performance facility provides DJ with a sturdy covered rectangular table at least 3x5 feet in an area within 25 feet of a 110 volt AC outlet (3 prong grounded) (unless table and/or self powered system is requested in above options line); (2) facility is open at least 90 minutes prior to scheduled start time and is accessible with a wheeled cart or dolly (La Boom must be notified at the time of booking if stairs or steps are involved as it might limit equipment set-up options); (3) facility meets all federal and state safety regulations and has all appropriate music licenses and performance permits necessary; (4) reasonable measures will be taken to protect La Boom's equipment, personnel, and music, and crowd control will be provided if warranted; (5) for outdoor performances, shelter is provided that completely covers and protects La Boom's equipment from adverse weather conditions (unless canopy is requested in above options line). Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions, unless La Boom is deemed negligent. In the event of circumstances deemed by the DJ to present a real or implied threat of injury or harm to the DJ, equipment, recordings, etc. DJ reserves the right to cease performance until Client resolves any such threatening situation. DJ can also deny any guest access to recordings or equipment. In the unlikely event a performance is delayed less than 1hr due to the D.J. tardiness, liability is limited to providing Client with performance time equal to time lacking. For delays more than 1hr after the designated starting time, which are the sole fault of the DJ, or music down time of more than 1hr during the scheduled time, liability will be limited to refunding the Client any payments made to La Boom for that event. La Boom reserves the right to take pictures of event performances and to use them for promotional purposes. Client feedback may be posted in referral section of website and/or be shared in correspondence with potential clients. La Boom holds all appropriate insurances for its equipment and personnel.
